#### 1. Call to Order, Welcome and Introductions

M. Vuong called the meeting to order at 5:04 pm.

## 2. Discussion: Communications Updates

A. Blue provided an update on the Executive Director.

M. Vuong asked for confirmation that everyone received the Communications update this month and then highlighted a few items: increased pressure washing funded by a grant from the Chris Larsen Fund, an advised fund of Silicon Valley Community Foundation, the Inviting Spaces and Safe Passage partnership, Four Corner Fridays are starting up again, the Safe Passage shift to an hourly model, and a Tenderloin Teen Night.

## 3. Update: Economic Opportunity Small Business Survey Presentation

L. Lewis summarized the key objectives of the small business survey.

H. Bean followed up with a presentation on the methodology, a map of the survey's 51 respondents, and details on the types of businesses surveyed. Recommendations from respondents are to: improve street conditions, support marketing programs, and provide financial support through an expanded mini-grant program.

The survey results are available on the TLCBD website and have been presented to OEWD and City Planning. A. Karkhanis stressed that this is an opportunity to practice how to keep data privacy a concern. E. Rodenbeck asked about the qualitative nature of participation. H. Bean responded that many businesses were already familiar with TLCBD and her in particular. A. Blue added that Economic Opportunity is developing an online directory of Tenderloin businesses.

# 4. Update: Tenderloin Community Action Plan Update with focus on Alternatives to Policing as it relates to Traffic Safety

E. Rozell presented on the Tenderloin Community Action Plan (TLCAP)—a partnership between TLCBD and the San Francisco Bicycle Coalition. Last year was the first year since Vision Zero started in 2014 that there were no traffic fatalities in the Tenderloin. He shared 5 recommendations, and next steps.

A. Karkhanis asked if any residential responses requested widening sidewalks and making them more green. E. Rozell affirmed that was requested only anecdotally–there were no direct questions around those ideas on the surveys.

E. Rodenbeck asked if there's a plan to deal with the entrenched resistance to some of the design options. E. Rozell responded that yes, City services are more willing now to work to address residential concerns rather than commercial as they did in the past.

#### 5. Update: TLCBD Board Application and Timeline

M. Vuong shared that the application is online and there are vacant seats for: business, property owner and resident categories. Applications will be accepted until 30 days before the June Board meeting.
