1. Call to Order, Welcome

M. Vuong called the meeting to order at 5:05 pm.

2. Update: Executive Director Report

K. Robinson provided updates on:

- Staffing updates-still seeking Director of Finance and exploring recruiting company to aid in search; Director of People & Culture is also scaling down his role and hours, so will be posting soon for his replacement
- SP15 Karaoke Fundraiser, Board of Supervisors Commendation, Holiday Tree Lighting at Boeddeker
- Grants: \$200,000 from Chris Larsen for Communications (FY24/FY25) and \$100,000 for youth mental health; \$50,000 from Hellman Foundation for building out CRM; TBD from Hellman & Friedman for office furniture
 - J. Pace: Don't have to go far in the neighborhood for help with the youth mental health program—St. Anthony's and Larkin Street Youth may be able to help.
 - K. Robinson: We intend to work within our network and will not be starting a new program.
- DMACC updates; HRC presentation
- Banners, Big Bellies, and billboard-new banners going up soon focusing on restaurants and nightlife
- Capital Campaign and video
- TLCBD in the media No new stories, but a few in the pipeline. We're writing an Op Ed to follow UC Law's.

5. Presentation: Camera Program and Al

K. Robinson introduced Dmitiri Shimolin from Applied Video Solutions (AVS) to help discuss building in Al efficiencies in the Camera Program.

D. Shimolin presented on the history of the Tenderloin Camera Network (grew from 10% coverage of the Tenderloin in 2016 to 60% in 2023), priorities for the network (Priority 1–Existing Camera Network Upgrades, Priority 2–Camera Registry and Video Retrieval, Priority 3–Camera Network Coverage

Expansion, Priority 4–Al Technology Evaluation, Priority 5–Infrastructure Improvements), and video request workflow.

- J. Pace: St. Anthony's has always been curious about cameras, what's the opposition to a camera network?
 - K. Robinson: I don't think there's opposition. It's the distinction between after the fact and monitored—we're closing cases, but we're not monitoring. If we were able to provide footage in 30 seconds, that would be valuable.
- K. Robinson: We're focused on the retrieval process, want to shift to shared ownership with property owners, and really take the time to explore Al and will put this forth to the funder. We're readying our infrastructure for this.
- M. Vuong: This is also really to support staff who have to view the video footage and support their wellness. Please email any questions. This is just the start of the conversation.

6. Discussion: 311 Recommendation from Ops & Stewardship Committee

- K. Robinson: The recent topic was 311 responses which go to the Clean Team.
- I. Manchester: The committee's recommendation is to pull out of the work and bring attention to the fact that the City is not doing any of this work.
- K. Robinson: We were hoping that this partnership would free up DPW to focus more on large item pickup, etc., but that never materialized.
 - G. Johnson: We still don't have the ability to do all of this work now, why should we stop?
 - D. Pang: How do we ensure without bending our backs that we're still meeting our baseline?
 - E. Looper: There was a strategy of just a morning contract, they gave us corridor cleaners, but they removed them, now we're going into a deficit.
 - J. Pace: TLCBD will end up putting the burden back onto the property owners and the City still won't respond, is that what we want?

[Action: There will be a follow up at the Operations & Stewardship Committee meeting; follow up at a future Executive Committee meeting can be scheduled if more interest is expressed.]

7. Discussion: Solidify Details for the January Board Retreat

- M. Vuong: Board retreat starting at the office on January 27th from 9AM-2PM.
- K. Robinson: Would like to focus on cleaning with guest Chip from Block By Block, and then having a tour of the neighborhood and our programs to end the day.

8. Discussion: Board Leadership in July 2024

M. Vuong: As most people probably remember, I'm on my very special fifth year as a board member. We're trying to plan for FY 24-25 Board leadership. Anyone interested is welcome to attend any of the weekly Tuesday meetings between Kate and myself. There is also an opportunity to bring on 3 new board members with 3 existing members terming off. Keep in mind that we can always use someone in finance, fundraising, and legal.

E. Looper: Our next Block Safety Convening meeting will be on January 4, 2024 at St. Anthony's, 12-1:30PM.

M. Vuong: Tree planting outside St. Anthony's tomorrow, December 21st from 10AM-1PM.

G. Johnson: If anyone is interested, the DA will be at 470 Ellis with La Voz Latina for a workshop on January 12th or 26th from 10AM-12PM.
