## 2. Update: Executive Team Report

Staff provided updates on:

- Hot Topics; Camera Sales Updates recently reported 68% drop in sales tax revenue in the
  Tenderloin; new Workforce Clean Team is breaking their own records for trash pickup-previously at
  ~80 bags/day and now at ~180 bags/day; in conversation with the Mayor's Office and seeking board
  members for an Ad Hoc committee to close out the Camera Program and sell it
- Workforce Team; Clean Team Swing Shift; DCYF Updates have moved 5 Workforce Clean Team members to Clean Team I; invested in additional Clean Team trucks; Job Fair planned for next Thursday; launched first swing shift–goes from 10AM-6PM); October 1st is launch of DCYF program with 8-14 interns
- People & Culture Updates streamlined onboarding; working on emergency action plan;
   cybersecurity; Greg is working in his new role as the Training and Development Manager
- Finance Updates on the back end of the audit–waiting on draft report (should have by 2nd or 3rd week in October); one of the biggest differences between this and last year was \$500,000 donated to Capital Campaign
- Grant Prospects Hirsch Foundation; Heising-Simons Foundation; Elevate Youth, MOHCD
- In the Media Mission Local; several Legislation stories; KQED
