- 1. Call to Order, Welcome

3. Program Spotlight: Focus on Large Projects and/or Challenges

Curtis, TLCBD Staff, discussed the history of the program, growth of program, challenges and strengths of program. Meeting members discussed the funding challenges and brought up the deferment of maintenance costs, a fee for service model and trying to convince the City government to help fund the program. SFPD probably can't contribute since they will demand live view access.

4. Program / Department Updates:

- Parks

 Jalil mentioned captains are fully staffed. There is a hiring freeze on other staff. They are trying to get SF Rec & Park to have a park ranger at Boeddecker Park. Interactions are the same. They are trying to get more participation from rangers on that issue.

- Safe Passage

Eric mentioned more progress was made on hiring and getting more volunteers to participate in the program. They are upping the requirement for bilingual skills since there is a need to communicate with all staff during emergencies and an increase in challenges during radio calls within the team. The Tenderloin Traffic Safety Task Force's 1st Annual Event is on Saturday, September 9th and Eric discussed efforts to have both SFMTA Hyde Street Projects completed at the same time rather than having them completed at two different times.

- Clean

- Huge volume of 311 requests. Within the first week of September they received 300 cases. They are handling 53% of all city wide 311 cases and over 90% of Tenderloin requests. The 600 block of Ellis has ongoing cleaning issues.
