- 1. Call to Order, Welcome

The meeting was called to order at 12:05 PM

- 2. Approve Last Meeting Minutes
 - There was a motion to approve with changes.
 - Motion: Isabel, second by Shelby, voted unanimously
- 3. Program Spotlight: Clean
 - 311
 - Kate reviews program, and notes it's been very helpful to have the data and reports. But it's very hard to track the impact it has on the baseline services. Do we keep the system or not?
 - All discuss the funding options and that they will only come via grants such as the one

- we applied for recently this is how we can expand our services
- Cindy it is valuable to have that system to serve as your dispatch, you don't want to get buried in phone calls instead
- Susie 311 is ubiquitous (throughout City), folks know about it, so it seems better known than dispatch; people know how to use it, access it with dispatch, not as many will know about it (so we may not get as buried in calls as we'd think) Also what about the benefit of systematic services...
- Pratibha didn't think 311 was a good thing because it took away from our normal schedule, I think if we continue to do 311 it will be the same story. Is there a way, I think we need to change something, I would not vote to keep 311. I think property owners like to be aware of when services are happening with the regular schedule, and we should be mindful of them as our lead 'members.' If we stop we need to make it public
- Cindy good to go back to a regular schedule, cleaning is the number 1. It's filthy, but how do we maintain the data we need for possible funding?
- Susie we have much data now
- Kate what if we went to BOS or requested a hearing? It is surprising how our pilot effort is unknown to many...
- Pratibha we don't have to wait for a commission hearing to pull away, make a statement, send a letter to Carla that we will step away from it. Request hearing with Streets & Sanitation Commission
- Isabel If there is no funding, we still need to make it forward moving; if we did pull out, how are we going to improve the current situation?
- Cindy still get the info from 311 but don't need to respond back, having a dispatch center will require too much manpower, a staff needs to answer the calls, critical that if we back out to make it stern and clear, City needs to know
- John calls go to a voice mail we pick up the next day
- How many still use the system 7 now
- Need to make sure we would still get access to 311s Kate notes app by Christian Martin has data (JIA), and it used to allow access to 311 data need to check on this
- All discuss the situation that the CBD did the work of DPW yet didn't get compensated for it. There is no official contract either. Also, it seems DPW rescinded regular work in the area. Unfair as they are a behemoth organization with so many resources.
- Need to call out DPW, but be strategic in timing due to the outstanding grant
- John what do we do in place of?
- Pratibha not difficult to share dispatch number, if they are there every week and have relationship, we can share fliers/info regularly.
- Susie Asks about other CBDs in the pilot, notes TLCBD is a special case and different than other neighborhoods, we need extra services, where is the equity? We could still advocate and make a case to DPW.
