# 1. Welcome & Call to Order and Approve minutes

- Meeting called into action at 12:06 pm by D. Williams
- Meeting minutes

### 2. Open House

- N. Flatey suggested the importance of reaching out directly to business owners, and providing services in their preferred language. N. Flatey expressed the need to have access to translators in order for TLCBD to best serve the small businesses in the area.
- G. Johnson amplified the obstacles of language barriers and how that creates inaccessibility to businesses in the area. He mentioned that currently there's no face of TLCBD and we need to be more present on the ground. How can TLCBD provide services when not everyone knows TLCBD or the resources it provides..
- D. Williams expressed that internally TLCBD is looking into drafting a Translation Policy lead by Director C. Salazar, we currently partner with internal staff to do most of our translation services.
- C. Salazar explained in depth the current draft of the translation policy and how it would create a task force for the immediate community. This policy would identify, with help of other CBO's, individual community members who can translate written materials and provide live interpretation during outreach, meetings, events, etc. All translators would be compensated fairly and the community would see an influx of wealth reinvested into the Tenderloin community through this.
- E. Rozell highlighted that the Safe Passage team does internal translation, however staff is not fully prepared to be expert translators. Live interpretation could be challenging as it could create unintentional distractions.
- N. Maisel mentioned that a translation policy is great. N. Maisel also mentioned that it may
  be difficult to attract members of the public to attend this P&V committee meeting due to
  conflicting schedules, N. Maisel suggested investing funds into paid focus groups to get
  community feedback.

• C. Salazar gave members of the P&V committee a mini training on the upcoming RFP 225

and what is expected of each board member as an active panelist to grade each application. Clarifications were made on the participation of the panelists if they apply for the grant and a timeline for the next steps was given. P&V committee will use most of October's committee meeting to review and make suggestions on the final grantees.
