### 4. DISCUSSION: TOPICS FOR FUTURE MEETINGS

- Keep topics central to what we would like to bring to the table.
- Purpose of this committee is to guide TLCBD staff on decision making, etc. more like a working group/taskforce.
- Susie mentioned that there's a lot of information going on within the subcommittees, it would be helpful to know what's going on on all committees to see where's overlap. Still believes that it might be hard to grasp all information.
- Kate shared the sense of urgency of the Mid Market Association in regards to the whole foods temporarily closing and how that can affect our community.
- Kate shared what would make this group successful; ultimately it should give our staff the backing they need to move forward. The goal is to find spaces where this committee supports TLCBD staff to uplift community voice.
- Cyntia shared that she would feel successful by creating a space within the committee where staff can bring difficult topics to the group and have discussions to then later be applied to the programs, etc
- Susie shared the new press release that Mayor Breed and if that's something of interest to the group and if directly impacts TLCBD
- Esan would feel successful if the committee knows the direction we are going and identifies the one thing every member of the committee feels connected to, and has a purpose.
- Esan is questioning if the space is right for this meeting. Would we have enough space for future meetings?
- Naomi shared La Cocina Marketplace could be a possible meeting space. Esan shared that The Healing Well could also be a potential meeting space.
- Nafi shared that if everyone works together we will create change.
- John shared how subcommittees will attend other subcommittee meetings to share out important info and bring information back to other Committees for continuity.
