  - E. Rozell shared in detail all the Pedestrian Safety Projects and Achievements from the last few years focused in the Tenderloin including:
    - Safer Taylor Street Project
    - Quick builds (Taylor, Golden Gate, Turk, Leavenworth, Hyde and Larkin)
    - Shared streets (Golden gate Greenway, Dodge Alley + Elm Alley)
    - Safe Intersections for all project (Traffic Signal Upgrades)
    - Pedestrian scrambles, Speed Cameras, No turn on red & 20MPH statewide
  - E. Looper explained how Policy & Voice intersects with E. Rozell work and how it helps uplift the community needs to the different coalitions and committees.
