**1. Welcome**

The meeting came to order at 5:01 pm.

**2. Update: Executive Director Report**

K. Robinson provided updates on:

Program and Staff:

TLCBD welcomed a new Administrative Specialist and is having two departures that include our People and Culture Director and Director of Community Organizing.

Camera:

Moving forward we will be transferring the camera program to the City of San Francisco using the original vendor SafeCity Connect.

Capital Campaign:

Still in negotiation with the Property owner to acquire the building.

Grant Funding:

We received funding for block groups from the Pisces Foundation. In addition, we received funding for The String Light Project, which covers 13 blocks, including the Safe Passage route from the Silicon Valley Community Foundation. Unfortunately, we did not receive funding from the Mayor's Office of Housing and Community Development. DPW grant - Reallocation of funds will go towards a graffiti "strike" team, pending approval from DPW.

**4. Discussion: Strategic Planning Discussion**

A. Blue provided updates on the following items:

- Financial Sustainability: Laying the Groundwork for Long Term Impact

Key strategies discussed included monetizing the camera network, expanding the clean team, janitorial and safety operations, strengthening engagement with donors and private foundations, building a reserve fund of \$2M+, and securing \$18M for the Capital Campaign.

- Workforce Development & Economic Mobility: Investing in Residents & Small Businesses, and in the people of the Tenderloin is crucial, including providing information on workforce readiness, offering financial literacy lessons, fostering partnerships among service providers

to help individuals become job-ready; through strategic partnerships, establishing a career training hub and trade school within the community.

-Community Resilience & Disaster: Implement a collaborative approach where all staff are trained in emergency response and aid, establish a cooling center and emergency access for the neighborhood, and coordinate evacuation and shelter efforts.

-Policy & Legislative Leadership: A stronger Voice for Change

Establishing a dedicated kids' zone to improve safety in the neighborhood. Address the concentration of social service that doesn't serve the youth by creating a more thoughtful strategy—making every development intentional. In addition, making progress on building the Tenderloin Community Center which is a part of the Capital Campaign that will serve for workforce training, small business support, family support center, etc.

M.Puchalski: How do we balance improving the tenderloin without slipping into gentrification?

K. Robinson: We are rich with affordable housing, which prevents a high risk of negative impacts of gentrification.
